Release & Waiver of Liability

EARTH DAY FUN RUN / WALK 5K

In consideration for receiving permission to participate in the Earth Day Fun Run / Walk 5K Race, I hereby agree forever to RELEASE, WAIVE, DISCHARGE, and COVENANT NOT TO SUE the University of Arkansas (UA), the University's Garvan Woodland Gardens (GWG), including but not limited to any of the UA, GWG, or faculty, staff, employees, agents, contractors, officers, board members, members or volunteers (the "Released Parties") for any and all personal injuries, death, or damages whatsoever, from whatever cause, supervised or unsupervised, including but not limited to negligence, resulting from participation in the Earth Day Fun Run.

I covenant and agree that by signing this release, I am waiving all known and unknown risks of harm, including but not limited to, the risk of running on a mountain trail, running on a street/highway with vehicular traffic, or running on a sidewalk, personal harm or death due to the length or steepness of the run, other runners, inclement weather, trail/road/sidewalk conditions, and failure to abide by all traffic/crosswalk laws. I covenant, warrant and represent and intend for the Released Parties to rely upon my representations that I am healthy and able to meet the physical requirements to participate in this race. I covenant and agree that I have been advised that this event will involve strenuous physical exercise and challenging conditions which may or may not be appropriate for me, and I have taken all steps I deem necessary to participate in the event and voluntarily accept all risk and desire to participate.

I fully understand that this outdoor activity is physically demanding and I am aware that it may involve hazards, and may involve risk of serious injury. I am voluntarily participating in these activities with knowledge and appreciation of the dangers involved and voluntarily agree to accept and assume risks of personal injury or damages. I recognize and acknowledge that this run involves a steep, narrow mountain trail and participants may encounter uneven footing, tree roots, rocks and other hazards.

I hereby agree that in the event any claim arising out of our incidental to personal injury or damages to me shall be filed against the Released Parties, I shall indemnify and hold harmless such Released Parties against any and all such claims, including attorney's fees incurred by the Released Parties in defending any such claims.

I have CAREFULLY READ this Release and Waiver of Liability and FULLY UNDERSTAND and am AWARE of its contents, and I sign it of my own free will.
